INFORMATION CLAUSE

Pursuant to Article 13 (1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (Journal of Laws EU L 119/1 of May 4, 2016, hereinafter referred to as GDPR, I inform that:

- 1. The administrator of your personal data is Gdynia Sport Center, hereinafter referred to as: "Administrator" with headquarters in Gdynia (81-538) at Olimpijska 5/9 street.
- 2. You can contact the Administrator through the data protection officer appointed by Administrator, by writing to the following address: iod@gdyniasport.pl.
- 3. Your personal data are processed only for the purpose of using the services of the Marina Gdynia, under Article 6 of the Act 1 point b GDPR
- 4. Providing personal data is not mandatory, however failure to do so will make the use of Marina Gdvnia services impossible.
- 5. The Administrator will not transfer your data to a third country or to international organizations.
- 6. Your personal data may only be transferred to entities authorized to obtain personal data on the basis of legal provisions.
- 7. Your personal data will be processed for a period resulting from legal provisions, until the completion of the objectives, and after that time for the period and to the extent required by the provisions of the Act of 15 July 1983 on National Archives and Archives and the Regulation of the Prime Minister of 18 January 2011 regarding office instructions, uniform material lists of files and instructions on the organization and scope of activities of company archives.
- 8. You have the right to request the Administrator to access your data, rectify them, transfer and delete them, and limit data processing provided that compliance with the request does not conflict with the GDPR and other legal provisions.
- 9. You have the right to lodge a complaint with the President of the Office for Personal Data Protection if you find that the processing of personal data violates the provisions of the GDPR.
- 10. Based on your personal data, the Administrator will not take automated decisions towards you, including decisions resulting from profiling *.

^{*} Profiling means any form of automated processing of personal data, which involves the use of personal data to assess some of the personal factors, in particular to analyze or forecast aspects of the work of individual, his economic situation, health, personal preferences, interests, credibility, behavior, location or movement.
